#### 1. PROJECT BACKGROUND

The project's overall objective is strengthening the rule of law in North Macedonia. The project has four specific objectives: 1. To improve the capacities of justice institutions to deliver justice in transparent and accountable manner, 2. To strengthen the capacities to effectively implement modern investigation techniques in fighting organised crime, 3. To improve the prevention and fight against corruption, and 4. To enhance the protection of fundamental rights.

The work will be carried out under Component 3 - Improving the Prevention and Fight against Corruption. One of the expected results of this component is to provide strategic support for ensuring effectiveness and efficiency in the operations of the State Commission for Prevention of Corruption (SCPC). This vacancy notice is drafted to support the implementation of activity 3.1.1 - "Support on strategic management and methodology development of SCPC".

#### 2. OBJECTIVES OF THE ASSIGNMENT

The environment, natural resources, and energy sectors are of strategic importance for North Macedonia's sustainable development, economic growth, and alignment with European Union standards. At the same time, they are highly vulnerable to corruption risks due to their complexity, significant financial flows, large-scale investments, licensing regimes, and regulatory decision-making processes. Corruption risks often emerge in areas such as environmental permitting, exploitation of natural resources, concession agreements, energy production and distribution, renewable energy investments, and the management of state-owned enterprises. Lack of transparency and















accountability in these processes can lead to misuse of resources, environmental degradation, distortion of energy markets, and a loss of public trust in institutions.

Given these challenges, the prevention of corruption in the environment and energy sectors requires a sector-specific approach based on specialised knowledge and international best practices. The State Commission for Prevention of Corruption (SCPC), as the key institution responsible for developing, coordinating and monitoring anti-corruption policies, needs specialised sectoral expertise to ensure that the forthcoming National Strategy for Prevention of Corruption and Conflict of Interest 2026–2030 (NACS) adequately addresses these risks. The input of a dedicated expert will ensure that the Strategy reflects both local realities and EU/international standards, while also promoting integrity, sustainability, and good governance in the management of environmental and energy resources.

#### 3. ROLES AND RESPONSIBILITIES

The engaged expert should closely coordinate their work with the Component leader, the SCPC leadership and the secretariat staff. The scope of work will cover expertise regarding the environment, natural resources, and energy sectors dimensions in the development of the NACS. The main tasks should include:

# 4. REQUIREMENTS

# General professional experience

- University degree in Law, Political Science, Sociology, Public Administration, Economics, or other fields relevant to the assignment.
- At least 7 years of general professional experience relevant to the assignment.
- Experience in conducting assessment analysis and/or conducting research analysis (qualitative and quantitative fields).
- Strong capacity to identify systemic risks, propose practical preventive measures, and formulate evidence-based recommendations.
- Excellent drafting and presentation skills.
- Ability to engage with multiple stakeholders, including government, independent bodies, civil society, and international partners.

# Specific professional experience

- In-depth understanding of governance and management in the environment, natural resources, and energy sectors, including infrastructure projects, concessions, procurement, and regulatory frameworks.
- Demonstrated professional experience in environment, natural resources, and energy policy, infrastructure governance, public procurement, or oversight mechanisms.
- Ability to assess corruption vulnerabilities in large-scale infrastructure investments, licensing procedures, and concession agreements.

### 5. CONTRACT AND REMUNERATION

The contract will cover services for 15 working days of the advertised assignment.

The selected local short-term expert on the prevention of corruption in the environment and natural resources and energy sectors will sign a service provider contract with the Ludwig Boltzmann Institute of Fundamental and Human Rights (gmr.lbg.ac.at) and must have a status of self-employed. It will be their sole responsibility to comply with all legal requirements for self-employment as well as to cover all related taxes and charges.















The remuneration will be provided according to the grant contract.
