In an era of strategic competition and complex security threats, the European Peace Facility (EPF) expands the EU's ability to provide security for its citizens and its partners. It enables the EU to provide all types of equipment and infrastructure to the armed forces of EU partners, in compliance with international human rights law and international humanitarian law.

The EPF is a fund worth **€17 billion**, including the dedicated **Ukraine Assistance Fund (UAF) of €5 billion**. It is financed outside the EU Budget for a period of seven years (2021-2027), with a **single mechanism** to finance all Common Foreign and Security Policy (CFSP) actions in military and defence areas.

SUPPORTING SECURITY AND DEFENCE GLOBALLY

With the EPF, the EU:



funds the common costs of military CSDP missions and operations;



supports Peace Support Operations led by international and regional organisations, as well as partner countries around the world;



strengthens the capacities of third States and regional and international organisations relating to military and defence matters.

MONITORING AND COMPLIANCE

The EPF includes measures to:

ensure an adequate risk assessment and mitigating measures in compliance with international human rights law, international humanitarian law and EU arms export laws;

monitor the respect of international law and commitments by the beneficiary;

allow civil society to report on violations of international human rights law and international humanitarian law.

Assistance under the EPF can be suspended or terminated any time by the Council in case of infringement and/or abuse.



ASSISTANCE MEASURES ADOPTED IN EASTERN EUROPE, THE WESTERN BALKANS AND THE MIDDLE EAST

EASTERN NEIGHBOURHOOD

- **Ukrainian Armed Forces** (EUR 3.5 billion) — military equipment (lethal and non-lethal) and maintenance, repair and refit services of military equipment to support Ukraine to defend its territory and population against the Russian aggression; (EUR 2 billion) – Ammunition package: reimbursement for EU member states' ground-to-ground and artillery ammunition and missiles donated to Ukraine from existing stocks or from the reprioritisation of existing orders; joint procurement of 155-mm-calibre artillery rounds and missiles;
 - (EUR 255 million) — EUMAM Ukraine: ammunition, military equipment and platforms designed to deliver lethal force as well as equipment and supplies not designed to deliver lethal force, transportation, custody, and maintenance and repair of the military equipment provided for supporting training;
 - (EUR 250 million) — additional contributions of Member States for non-lethal support to Ukraine;
 - (EUR 31 million) — medical equipment, demining and engineering equipment, ground mobility, logistical assets and cyber-defence
- In addition, the EU has mobilised EUR 3.4 billion from windfall profits generated from immobilised Russian assets channelled through the EPF for the delivery of ammunition and air defence equipment. Out of that amount, EUR 1.5 billion were allocated to procurement from the Ukrainian defence industry.
- **Armed Forces of the Republic of Moldova** (EUR 317 million) — provision of short- and medium-range air defence systems, medical equipment, explosive ordnance disposal, logistics, mobility, command and control, cyber defence, electronic warfare, unmanned aerial reconnaissance, air surveillance and tactical communications.
 - **Georgian Defence Forces** (EUR 62.75 million) — three assistance measures to date for the provision of equipment in the medical, engineering, ground mobility, logistics, cyber defence, and command and control spheres;
 - **Armenian Armed Forces** (EUR 30 million) — equipment to strengthen the logistical capacities of the Armenian Armed Forces through the provision of a fully-fledged deployable tent camp for a battalion-sized unit

WESTERN BALKANS

- **Armed Forces of Bosnia and Herzegovina** (EUR 35 million) — demining equipment, transport and medical vehicles — field equipment, key tools for military engineering and CBRN (Chemical, Biological, Radiological and Nuclear) Material – individual protective equipment, CBRN protective equipment, night vision devices and mobility assets
- **Balkan Medical Task Force** (EUR 6 million) — mobility assets, medical components, laboratory, IT and communication equipment
- **Army of North Macedonia** (EUR 38 million) — logistics support, medical, engineering equipment, information and communication systems, intelligence capacities, mobility and engineering vehicles and training equipment
- **Albanian Armed Forces** (EUR 49 million) — light armoured multipurpose vehicles, tactical and engineering vehicles, related supplies and services, including technical training
- **Armed Forces of Montenegro** (EUR 6 million) — real life support equipment, equipment for CBRN (chemical, biological, radiological and nuclear) operations, equipment for helicopter-borne search and rescue units

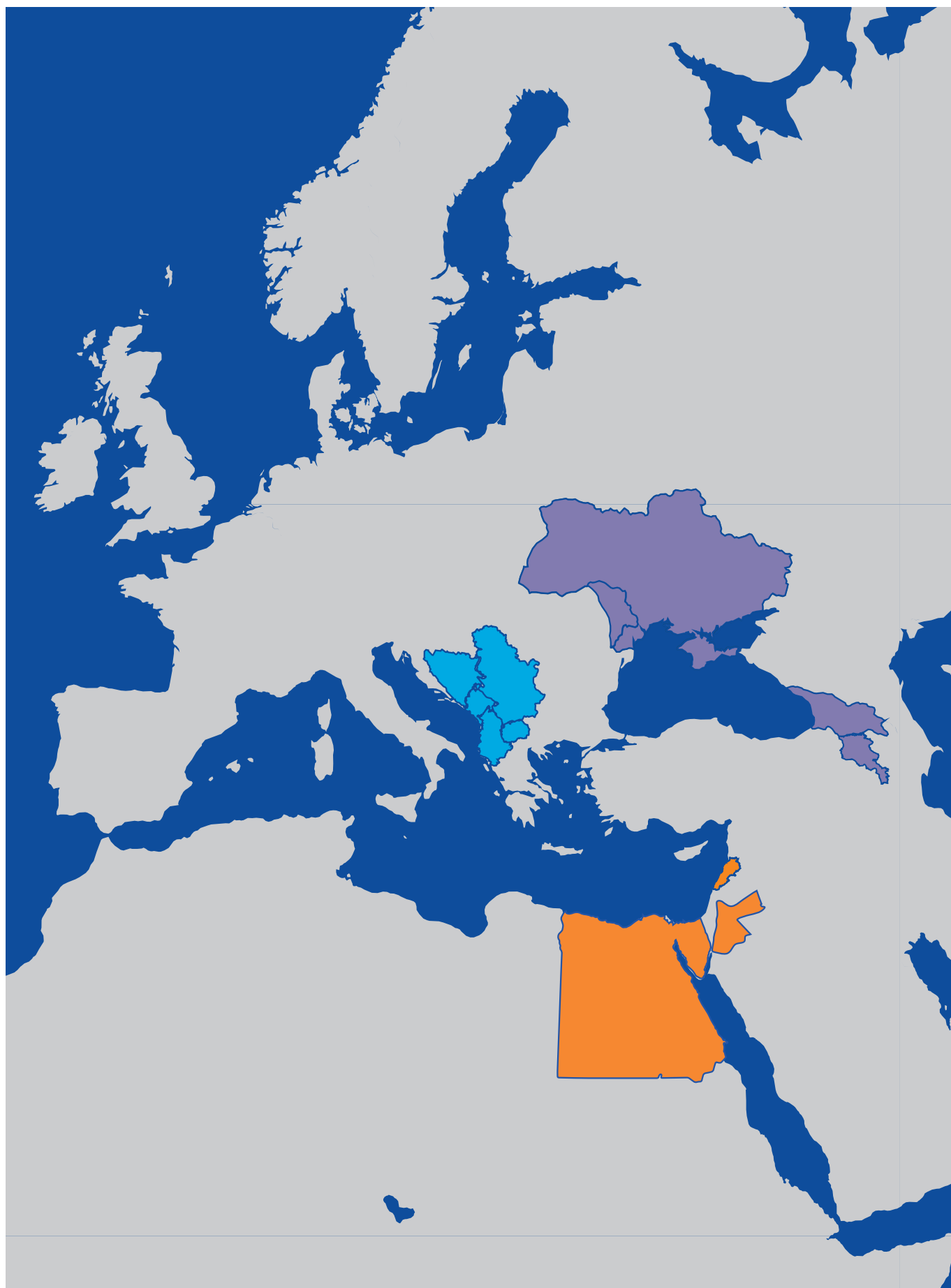
MIDDLE EAST

- **Lebanese Armed Forces** (EUR 182 million) — military medical equipment and services, personal equipment and supplies, engineering works and combat engineering equipment, infrastructure and field support equipment, mobility equipment including Armoured Personal Carriers (APC), operational drone systems, integration of maritime surveillance assets, Counter Unmanned Aerial Systems (C-UAS)
- **Jordanian Armed Forces** (EUR 55.25 million) — military medical services, engineering support, detection and counter Unmanned Air Vehicles systems (c-UAV) and air defence
- **Egyptian Armed Forces** (EUR 40 million) — light armoured patrol vehicles, small Unmanned Aerial Vehicles systems, light and mobile radars, goggles with night vision features, protection and detection equipment for maritime security, and logistics and communication equipment.

ASIA-PACIFIC

- **Armed Forces of the Philippines** (EUR 15 million) – coastal radar systems, electro-optical and infrared surveillance systems, radar electronic support measures.

ASSISTANCE MEASURES ADOPTED IN AFRICA

- **Mozambican Armed Forces / EU Training Mission in Mozambique** (EUR 89 million) — ground and amphibious mobility assets, technical devices and a field hospital
- **Rwanda Defence Force in Mozambique** (EUR 40 million) — personal equipment, strategic airlift
- **Armed Forces of Mauritania** (EUR 55 million) — intelligence, surveillance and reconnaissance (ISR) - Unmanned aerial systems (UAVs), mobile land surveillance assets -, quads, light boats and patrol boats - including spare parts and maintenance training -, individual equipment, medical equipment, multi-purpose aeronautical equipment, AWD vehicles, floating docks, two naval assets of 33 M category
- **Ghana Armed Forces** (EUR 33.25 million) — such as medical, imagery, engineering, electronic warfare and explosive ordnance disposal equipment
- **Democratic Republic of the Congo** (EUR 40 million) — individual equipment and collective equipment for the 31st Rapid Reaction Brigade of the FARDC as well as infrastructure rehabilitation of the brigade's headquarters; medical support, communications, military engineering, and river navigation equipment for other units of the FARDC
- **Republic of Congo** (EUR 10 million) — training in naval education and equipment for specialised workshops; Intelligence, Surveillance and Reconnaissance (ISR) assets for a radio command post, and complementary equipment for the operations and crisis management rooms; specialised equipment for Visit, Board, Search and Seizure teams and naval divers
- **Beninese Armed Forces** (EUR 56 million) — intelligence, surveillance and reconnaissance (ISR) aircraft and Unmanned Air Systems, multipurpose military aircraft, training aircraft, including simulators, spare parts, and training of pilots, instructors, and aircraft mechanics, command and control capacities, equipment needed for the collection and analysis of intelligence of military interest, individual protective equipment, medical equipment, training ammunition and small arms for operational purposes.
- **Gulf of Guinea (Ghana and Cameroon)** (EUR 31 million) — Surveillance and Reconnaissance services to the Yaoundé Architecture and non-lethal equipment to the navies of Ghana and Cameroon, such as of Rigid Hull Inflatable Boats/ intervention speed boats, engines, light Naval Rotary Unmanned Air Vehicles, marine generators for ships and scuba diving equipment
- **Somali National Army** (EUR 1 million) — ammunition for training Somali National Army personnel in conjunction with EU Training Mission in Somalia
- **Kenya Defence Forces** (EUR 20 million) — tactical unmanned aerial vehicles, non-lethal interceptors and jammers, systems to defeat improvised explosive devices, electronic warfare means, cross-country tactical military-type vehicles, a mobile medical post, night vision goggles, life vests, and personal protective equipment
- **Armed Forces of Cote d'Ivoire** (EUR 40 million) — Intelligence, surveillance and reconnaissance (ISR) capabilities and Unmanned aerial systems (UAVs), multi-purpose ground vehicles and personal protective equipment
- **Gulf of Guinea (Benin)** (EUR 5 million) — on-the-job training in naval education and assistance to support efforts to bring back patrol boats to operating conditions, equipment of ship maintenance workshops, outboard engines, surveillance boats, and personal protective equipment
- **Senegalese Armed Forces** (EUR 29.2 million) — day-and-night land and river surveillance, intelligence gathering and force protection, support to naval operations and education including in the framework of the Yaoundé Architecture
- **Armed Forces of Cabo Verde** (EUR 15 million) — equipment and services related to patrolling and surveillance, including delivery of an ocean patrol vessel and training activities
- **Togolese armed forces** (EUR 15 million) — — engineering and logistics equipment, individual protective equipment, equipment for combatting explosives, maritime surveillance and communication capabilities, naval maintenance and support equipment, and naval intervention means
- **Djibouti Armed Forces** (EUR 20 million) — restoration of part of the Djiboutian maritime assets, a coastal surveillance station including functional intelligence, surveillance and reconnaissance assets and rapid intervention assets for the Djiboutian Navy
- **Armed Forces of Chad** (EUR 14.5 million) — refurbishment and infrastructure works at the École Nationale des sous-officiers d'active de Koundoul (ENSOA-K)

ASSISTANCE MEASURES ADOPTED IN AFRICA

Continuation of support to military components of African-led Peace Support Operations as previously funded under the African Peace Facility. Two assistance measures taking the form of general programmes for support to the African Union in 2021 (EUR 130 million) and 2022-24 (EUR 604 million), under which so far:

- **Successive African Union-led missions in Somalia (AMISOM, ATMIS, AUSSOM)** (EUR 415 million) — support to the military components of AMISOM, ATMIS, and AUSSOM, including troop allowances for personnel deployed in Somalia, as well as the provision of non-lethal equipment and related services, with a view to enabling the gradual handover of security responsibilities to the Somali Security Forces
- **Somali National Army** (EUR 89 million) — works on military infrastructure, including military training facility, provision of command, control and communication equipment, ground mobility, systems to defeat improvised explosive devices, medical equipment and reconnaissance equipment, to enhance the capacity of the Somali National Army to implement the Somali Transition Plan
- **Multi-National Joint Task Force against Boko Haram - MNJTF** (EUR 180 million) — functioning of the MNJTF HQ in N'Djamena, air and ground transportation, medical services Command, Control and Communication Information system (C3IS), surveillance equipment, counter-IED equipment, nautical means
- **G5 Sahel Joint Force** (EUR 17 million) — following the withdrawal of Mali, Burkina Faso and Niger, support to strengthen the resilience of the Mauritanian armed forces and to rehabilitate the Chadian logistic stronghold and airstrip in Wour
- **Southern African Development Community (SADC) Mission in Mozambique (SAMIM)** (EUR 15 million) — support to the military component of SAMIM including camp fortifications, medical equipment, vehicles and boats, as well as technological devices
