EU Drawing Contest "Tahun Pemilu: Merayakan Demokrasi"

Introduction

The European Parliament elections as well as the Indonesian elections are set to take place in 2024. To mark these significant events, the Delegation of the European Union to Indonesia seeks to engage young Indonesians in our drawing contest "**Tahun Pemilu: Merayakan Demokrasi**" (The Year of Elections: A Celebration of Democracy).

Our aim is to highlight the importance of democracy in our lives and the role of elections. To that end, we ask young people participating in the contest to create a drawing relating to the theme. Contestants can be as creative as they would like but some suggestions to consider are: free and fair elections, performing our civic duties and being an informed citizen, political inclusion of marginalised groups (women, senior citizens, people with disabilities, indigenous peoples etc.), combatting fake news and electoral disinformation, first-time voters and others.

The contest is scheduled to run until 3 December 2023.
Around 200 entries are expected.
12 contest winners will be announced in mid-December 2023.

Terms & Conditions

The Delegation of the European Union to Indonesia (hereinafter referred to as "EU Delegation") is launching a drawing contest themed "Tahun Pemilu: Merayakan Demokrasi" (hereinafter referred to as "contest") and published on the website:

1. ELIGIBILITY OF CONTESTANTS

- a. The contest is open to Indonesian citizens, domiciled in Indonesia and age 17-30 years old by the final day of submission.
- b. One person is allowed to submit a maximum of 3 (three) drawings.
- c. Only individual drawing is accepted. Collaboration or group drawing is not eligible.

2. ELIGIBLE ENTRY

- a. The drawing must reflect the theme of the contest: "**Tahun Pemilu: Merayakan Demokrasi**".
- b. The drawing must not depict any particular politicians or political parties.
- c. The drawing must be original, unpublished and unproduced.

- d. The drawing must be the contestant's original concept – plagiarism or 'sampling' or 'tracing' of any kind is not accepted and will result in disqualification of the entry.
- e. Any drawing posted online – anywhere other than a personal blog – is considered published, and will not be eligible.
- f. Any drawing that has been submitted to other contests or has been previously exhibited or sold is not acceptable. We reserve the right to request proof that an entry is the original drawing of the contestant and created solely by the contestant for this contest. Non-compliance to this rule will result in disqualification of the entry.
- g. The use of Artificial Intelligence (AI) art, or generative art, to create the drawing is prohibited, not accepted and will result in immediate disqualification of the entry.
- h. The drawing cannot contain third party copyright logos or material. Upon submitting a drawing to this contest, the contestant is solely responsible for any infringement of copyrighted materials.
- i. A drawing that is deemed inappropriate will be disqualified.

3. DRAWING SPECIFICATIONS

- a. The drawing must be in square format (1:1 ratio).
- b. The drawing can be in the form of traditional art (hand drawing) or digital format.
- c. The submission of the drawing should be in digital format (scanned version is allowed).
- d. Size: resolution minimum of 300 dpi and should be between 2 MB and 5 MB.
- e. File types accepted: .png .jpg .pdf. Contestants should be prepared to submit the original file in higher resolution if the drawing is chosen as winner.
- f. File name should use the following convention:
[MerayakanDemokrasi]_[Name of Contestant]_[Domicile]

4. SUBMISSION REQUIREMENTS

- b. The EU Delegation may exceptionally agree that other means of submission can be used (e.g. due to technical constraints in completing the online Entry Form). Please raise your issue to the Organising Committee via email before the contest deadline at: eudrawingcontest@gmail.com
- c. Participation in this drawing contest is free-of-charge.

5. JUDGING

- a. 12 (twelve) winner will be selected based on:
 - Interpretation and clarity of the theme
 - Creativity, uniqueness and originality
 - Quality of artistic composition
- b. The decision is final.

6. PRIZES

- a. Each of the 12 winners will be awarded 1 (one) unit of a 14 inch-laptop and a certificate of recognition from the EU Ambassador to Indonesia.

- b. Under no circumstances may the prizes be subject to change or alteration at the request of contestants.

7. KEY DATES

- a. Deadline: **Sunday, 3 December 2023 at 23:59 Jakarta time (GMT+7)**
- b. Winners will be announced in mid-December 2023.
- c. Prizes and certificates delivery will be arranged after the winners announcement.
- d. The EU Delegation reserves the right to modify the dates and announce it in a timely manner on the contest website.

8. ASSIGNMENT OF RIGHTS

- a. By entering the contest, contestants confirm that they hold all intellectual property rights of the drawing.
- b. Without prejudice to the Terms and Conditions, the EU Delegation recognises that the copyright of the drawing created by a contestant remains with the contestant. Any enquiries for copyright will be referred to the contestant.
- c. Winners grant the EU Delegation a non-exclusive, non-profit and royalty-free right of use, dissemination, distribution, public communication, reproduction and exhibition of their winning drawing without prior notice. Credit/ acknowledgement of the winner's name will be given when the drawing is used by the EU Delegation.

9. DATA PROTECTION

- a. The EU Delegation process personal data in accordance with Regulation (EU) 2018/1725 of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data. - b. By completing the entry form, the contestant agrees to the EU Delegation collecting, processing, storing or otherwise utilising the contestant's personal data solely for the purposes of conducting and administering the contest, delivering the prizes to the winners and sending communications with information about the contest.
