To mark Kartini Day, the European Union is joining the celebration by organising a drawing contest for Indonesian youth aged 15 to 20. Contestants are invited to express their creativity through original artworks inspired by the theme:

## Colours of Equality: Imagining the Future of Women and Girls in Indonesia

The contest runs from 21 April 2025 (Kartini Day) to 25 May 2025. Twelve (12) winners will be announced on 30 June 2025.

### CONTEST TERMS & CONDITIONS

The **Delegation of the European Union to Indonesia** (hereinafter referred to as the “EU Delegation”) is organising the “**Colours of Equality: Imagining the Future of Women and Girls in Indonesia**” **Drawing Contest** (hereinafter referred to as the “contest”), published on the following website: <https://eeas.europa.eu/indonesia>

### CONTESTANT ELIGIBILITY

- The contest is open to **Indonesian citizens** residing in Indonesia who are **between 15 and 20 years old** at the contest’s closing date (the final submission day).
- Each contestants may submit a **maximum of three (3) artworks**.
- Only **individual contestants** are allowed. **Collaborative or group works** are not eligible.

---

### ARTWORK REQUIREMENTS

- The artwork may show **how Indonesian women and girls are already empowered, while envisioning a future where their potential is even more fully realised**.
- Contestants may use **various drawing styles, techniques, and visual elements** to strengthen their message.
- The submitted artwork must be the contestant’s **original concept**—**plagiarism, sampling or any form of copying is strictly prohibited** and will result in disqualification.
- The artwork must be **original, free of copyright restrictions, unpublished and unproduced**.
- Any artwork that has been **posted online (except on a personal blog), exhibited, submitted to other contests or sold previously** is ineligible.

- The EU Delegation reserves the right to **request proof of originality**, confirming that the submitted artwork was solely created for this contest. Non-compliance will result in disqualification.
  - **AI-generated artworks are strictly prohibited** and will result in **immediate disqualification**.
  - The artwork must not contain **logos or copyrighted materials** from third parties. Contestants are fully responsible for any copyright violations.
  - Any artwork deemed **inappropriate** will be disqualified.

## ARTWORK SPECIFICATIONS

- The artwork **must not** include **watermarks, timestamps or borders**.
  - It must be in **square format** (1:1 ratio).
  - The artwork can be either **hand-drawn and scanned** or **created digitally**.
  - Submission must be in **digital format** (scanned versions are acceptable).
  - **Resolution:** Minimum **300 dpi**, file size between **2MB and 5MB**.
  - Digital artworks must use the **CMYK colour model**.
  - Accepted file formats: **.png, .jpg, .pdf**.
  - Contestants must be prepared to submit **high-resolution versions** of their artwork if selected as a winner.
  - Submitted files must follow this naming format: **[ContestantName]\_[City]\_[Artwork#1,2,3]**.

## HOW TO PARTICIPATE

  - The EU Delegation may consider **alternative submission methods** for contestants facing technical difficulties with online registration. Please contact the committee via email before the deadline at [eudrawingcompetition2025@gmail.com](mailto:eudrawingcompetition2025@gmail.com)
  - **Participation in this contest is free of charge.**
  - Contestants must also submit a **description** of their artwork in **Bahasa Indonesia**, along with an **English translation** (max 150 words).
  - Entries that do not comply with the stated requirements will be disqualified.

## JUDGING CRITERIA

Twelve (12) winners will be selected by a **jury panel from the EU Delegation**, based on:

- **Relevance** – Adherence to the theme and contest rules
- **Originality** – Uniqueness and innovation of the artwork

- **Concept & Creativity** – The idea behind the artwork
- **Artistic Composition** – Overall visual appeal (use of space, lines, layout, and colours)

The jury panel's **decision is final**.

- **Submission Deadline:** Sunday, 25 May 2025 at 23:59 Jakarta time
- **Winners Announcement:** Monday, 30 June 2025

The EU Delegation's contest committee will notify each winner via **email** (as provided in the registration form). The delivery of **prizes and certificates** will be arranged after the winners are announced.

The EU Delegation reserves the right to **change the contest schedule**, with all updates to be announced on the contest website.

## ARTWORK USAGE RIGHTS

- By entering the contest, contestants confirm **they own all intellectual property rights** to their artwork.
- The EU Delegation acknowledges that **the copyright remains with the contestant**. Any copyright-related inquiries will be referred to the contestant.
- **Winners grant the EU Delegation a non-exclusive, non-commercial, royalty-free right** to use, distribute, display, reproduce, and include the artwork in public exhibitions without prior notice.
- If used, the **artist's name will always be credited**.
