The European Union is a long-term partner of Iraq and co-chaired the International Conference for the Reconstruction of Iraq in Kuwait in 2018.

More than €1.8 billion

EU assistance to Iraq since 2011, and €533.9 million provided in response to the Syria crisis, have contributed to:



Providing income-generating and cash-for-work opportunities to over **13,000 refugees** and host community members.



Offering employability, vocational, and entrepreneurial skills training to more than **39,000 refugees, IDPs, and host community members**.



Supporting 5,000 micro, small, and medium-sized enterprises.



Delivering over **142,000 primary healthcare consultations** to refugees, IDPs, and host community members.



Training more than **4,800 healthcare staff** in maternal and childcare, and upgrading or constructing **99** healthcare facilities.



Ensuring access to safely managed water for more than 177,000 refugees, IDPs, and host community members.



Providing protection services to **over 45,000 refugees, IDPs, and host community members.**



Demining 3,783,938 m² of land.



More than €119 million

in Humanitarian assistance

Protection: to support access to civil documentation, case management, mental health and psychosocial support, and protection in detention.

Multi-purpose Cash Assistance: temporary cash assistance was provided alongside protection services, enabling beneficiaries to obtain documentation and facilitating their inclusion in national welfare schemes.

Education in Emergencies: ensuring access to education for children in protracted displacement. Including catch-up classes, basic literacy and numeracy skills, and remedial classes to help children transition back into formal education.
