The 3rd EU-GCC Business Forum

The EU-GCC Dialogue on Economic Diversification project is an EU funded project managed by the Service for Foreign Policy Instrument (FPI). As part of its ongoing program to trade and investment co-operation between the EU and the GCC, the project organized the 3rd EU-GCC Business Forum in Kuwait on 19th and 20th March 2019. The forum was hosted in collaboration with project partners Kuwait Chamber of Commerce and Industry, the Kuwait Direct Investment Promotion Authority and the Supreme Council for Planning and Development.



The two-day forum attracted over 470 people with extensive participation from key decision makers in both the GCC and European Union. It gave the delegates an exceptional opportunity to network with key government officials and representatives, European and GCC policy makers, senior private and public sectors officials in addition to entrepreneurs and SME representatives.

The Gala Dinner held at the Al Hashmi Boat ballroom on March 19th, featured opening speeches from H.E. Ali Al Ghanim, Chairman of the Kuwait Chamber of Commerce and Industry, H.E. Abdul Latif bin Rashid Al Zayani, Secretary General of the Secretariat of the Cooperation Council for the Arab States of the Gulf, H.E. Michele Cervone D'urso, EU Ambassador to the Delegation of European Union to Bahrain, Kuwait, Oman, Qatar and Saudi Arabia, H.E. Dr. Sheikh Meshaal Al Sabah, Director General of the Kuwait Direct Investment Promotion Authority KDIPA, HE Dr. Sami Abdullah Al – Abidi, First Vice Chairman of the Federation of GCC Chambers and Chairman of Board of Council of Saudi Chambers and Dr. Khaled Mahdi, Secretary General, General Secretariat of the Supreme Council for Planning and Development. The event's opening speeches highlighted the importance of the EU-GCC business forum as a vehicle for informing and exploring trade and business opportunities arising from the ongoing GCC economic diversification strategies and the corresponding projects underpinning them particularly in key economic sectors where representatives from the GCC and EU presented ongoing initiatives and planned investments.

The second day of the forum featured keynote speeches and panels dedicated to

Roundtable with EU

Entrepreneurship and SMEs met with European business representatives in Kuwait on March 19th to better understand the challenges that EU companies face while operating in Kuwait and the GCC region as whole. During his meeting Mr. Mamer reiterated, that the EU is firmly committed to strengthening the relationship with GCC countries. Mr. Mamer stressed the commitment of the EU to work to assist European companies in removing barriers to trade and investment to enable them to better succeed in the competitive GCC market.

DG Grow: Galileo Satellite Navigation System Workshop

The EU-GCC Dialogue on Economic
Diversification project team in
collaboration with the European
Commission in the UAE and DG GROW
organized a 3-hour workshop on the
features, functions and potential
applications arising from the
development of the Galileo satellite



navigation system program by EGNSS and to promote its use to potential UAE users and software developers. During the workshop the speakers and the workshop attendees discussed in depth the viable opportunities to use navigation signals to develop user services reflecting the particular needs of GCC commercial and domestic users. Opportunities were further identified in sectors where the GCC has competitive strengths and advantages such as logistics but also opening up commercial services for private users such as geographic customer targeting, enhanced customer delivery services and more effective vehicle routing saving both costs and generating environmental benefits.

February 5

Keynote Address in Bahrain:

"Support for High Growth SME's - Actions and Impacts"

Mr. Aitkenhead, Trade and Foreign
Direct Investment Adviser on the EU-GCC
Dialogue on Economic Diversification
project presented to over 100 SME's and
staff of SME support agencies in Bahrain
on Tuesday 5th February on the topic
'Support for High Growth SME's – Actions



and Impacts". The presentation drew on the experience of a project in Jordan managed by the European Investment Bank (EIB) and financed by the G7 Deauville Partnership - MENA Transition Fund, through the EIB Facility for Mediterranean Investment and Partnership (FEMIP). This SME Growth Programme was designed to support SME's who demonstrated the greatest growth potential. The project was tailored and customized to meet the specific growth needs and the removal of barriers to growth identified by SME's. After his keynote address and presentation, Mr. Aitkenhead participated in a panel discussion with representatives of the Bahrain Small and Medium Enterprises Society and the newly established 'Export Bahrain' organization. The lively dialogue between panel members and the audience focused on the issues and challenges facing SME's in Bahrain such as the quality of the business environment particularly the complexity of licensing and permitting systems and most effective ways of addressing these.

January 16

Youth Employment Workshop

Earlier this year, the EU-GCC Dialogue on Economic Diversification project team in



collaboration with European Delegation in Saudi Arabia participated in a workshop addressing the topic of youth unemployment in the GCC and introducing potential models developed in the EU that may be used in the GCC to better address the issue. The workshop featured speakers from the Employment Strategy Division at the European Commission, the Employment Agency of the Brussels Region "Actiris" and from Ministry of Economic Affairs and Employment of Finland. The speakers highlighted various initiatives being undertaken in Europe the 'Youth Guarantee' - a commitment by all Member States to ensure that all young people under the age of 25 years receive a good quality offer of, employment, continued education, apprenticeship or traineeship within a period of four months of becoming

unemployed or leaving formal education to ensure that youth are well prepared and equipped with the necessary hard and soft skills to meet employers' requirements.

Women & Leadership Event

The Women & Leadership event held by the Embassy of the Kingdom of the Netherlands in Abu Dhabi and the Netherlands Consulate-General in Dubai, in collaboration with the EU-GCC Dialogue on Economic Diversification.



The event aimed to connect Emirati leaders and entrepreneurs, who have paved the way for women's empowerment and economic growth, with Dutch and other European female influencers in the UAE. The gathering consisted of two components: a panel discussion and a networking event. In the panel discussion, moderated by Samia Hasan from 'Unwind the Grind', selected high level female participants from the private and public sector, such as H.E. Amna Al Nakhi Director General Sharjah Government, Anissa Abbou Head of Global Professional Specifiers Relations at Signify, Lian Vergeer-Langens Head of Brand, Comms & Digital - Philips ME & Turkey and Siegrid Althuizen CEO at Skyne Creative Visionaries, shared their insights into the challenges they face and how to overcome them, but also shared their own personal stories, in order to support the participating entrepreneurs and future leaders in their professional and personal development. The networking reception gave the opportunity to connect, and to exchange ideas and best practices, but also to established new contacts with a selected group of leading Dutch and EU entrepreneurs in the Middle East
